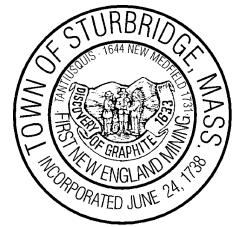

Throughout the month certified department personnel properly installed 8 child safety seats for town residents.

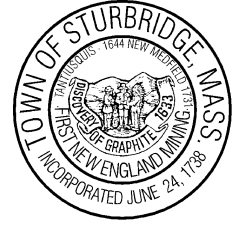
K9 Assists 5 activations in town and 3 mutual aid calls.
