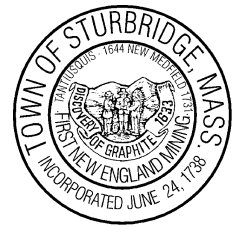

May 23 Officer DaDalt attended Proactive School Intervention training in Webster.

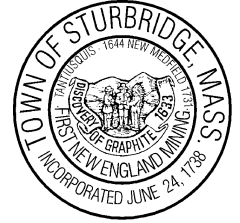
